The ROSTER reflects employees' current distribution of pay for the period noted above, residing in PPS at the time the ROSTER is pulled.	First day the ROSTER and CHECKLIST are available for associated pay day. Once the roster is available for a particular payday, departments should consider how processing EDB updates may affect the roster for an employee whose time is entered on the ROSTER. It is not required that ROSTERS be pulled on the first day they are available; however, any changes to the EDB after this date will impact ROSTER transactions, so EDB update must be carefully coordinated with ROSTER time reporting.	This is the last day to update the EDB in order to have changes reflected on initial ROSTER. ROSTERS are produced after PPS is taken down for the evening and available as noted in previous column. This generally falls on the Tuesday before the pay period end date, unless there is a holiday.	This is the last day to update or change the EDB in order to have changes reflected on the ROSTER. This is also the last day a new-hire can be entered in PPS to be reflected on the ROSTER and in CruzPay for Student employees.
